Introductory Workshop

Our starter level workshop will introduce participants to the practice and procedures of Dispute Boards (DB and DAB) and use case studies to involve the participants in considering the processes of establishing and working with Dispute Boards as well as examining the contractual basis for their operation. It is aimed at construction consultants, engineers, contractors, lawyers and employers who wish to gain more experience and knowledge in the use of DBs in construction projects, for those who are potential users of DBs, and for those who are potential DB members.

At the end of the course:

Participants will be able to possess the understanding of the Dispute Board concept and further to:

- Describe in broad terms the relevance of FIDIC to the DB process,
- Describe the role of a DB and be familiar with the related standard contract clauses,
- Undertake the process of appointing a DB member,
- Describe the role of the DB in dispute avoidance,
- Describe the basic process of DB throughout the execution of the construction contract,
- Have good comparative command on the rules regulating the DBs under the FIDIC and ICC Rules and Procedures.

Advanced Workshop

This interactive workshop will build on the knowledge of the practice and procedures of DBs and will provide more complicated cases and issues examining the mechanics of usage and acting as a DB member. It is aimed at construction consultants, engineers, contractors, lawyers and employers who are already experienced in the use of DBs in major construction projects and wishes to gain deeper knowledge in the field, for those who are users of DBs, and for those who already or are potential DB members.

At the end of the course:

Participants will be able to make the best use of a Dispute Board, and/or possess the understanding to act as a DB member, and further to:

- Undertake the process of appointing a DB member,
- Assess whether a DB member has a conflict of interest in undertaking a DB appointment,
- Identify the scope and limitations of the of the DB member's powers and duties,
- Strengthened knowledge on the DB procedural rules with specific focus on site visits, referrals and hearings,
- Have good comparative command on the rules regulating the DBs under the FIDIC and ICC Rules and Procedures.
